Notes for Applicants:

1. Before filling in the application form under the Subsidised Sale Flat Scheme (“the Scheme”), applicants should read carefully the application guide.
2. Applicants should fill in all the information required in the application form.
3. Please fill in the application form in English block letters (and Chinese if applicable) with a black ball pen and sign against amendments, if any. No correction materials such as correction fluid or tapes for obliteration should be used.
4. At the time of submitting the application form, applicants are only required to submit a completed and signed application form together with an application fee of HK\$200 (in the form of a crossed cheque or cashier order made payable to “Urban Renewal Authority”). Hong Kong Identity Card number and contact telephone number of the applicant must be written by ball pen at the back of the cheque or cashier order. **The completed and signed application form together with the application fee should be submitted to the “Subsidised Sale Flat Scheme Units” Applications Processing Section by mail to the “Subsidised Sale Flat Scheme Units” Applications Processing Section, G.P.O. Box 8840, Hong Kong on or before the closing date of application (according to postmark date) (Please mark “Subsidised Sale Flat Scheme Units” on the envelope).**

6. Applications which are mailed after the closing date of application will not be accepted. For submission by mail, the submission date is determined by the postmark date. Those applications with postmark date after the closing date of application will not be accepted. Those applications which are delivered belatedly or returned to the applicants due to insufficient postage will not be processed.
7. The assessment of applications will be handled by the Hong Kong Housing Society.
