1. General provisions: 一般規定： <ol style="list-style-type: none"> 1.1 Specified residential properties are offered for sale to individuals only. Corporate purchaser(s) shall not be entitled to purchase any of the specified residential properties listed in this Sales Arrangements. 指明住宅物業僅出售予個人。以公司名義登記之買方不可購買本銷售安排所列之任何指明住宅物業。 	

- 1.2 A person may only purchase one (1) specified residential property in the Development. If a person is not the sole purchaser of but is one of the persons comprising the purchaser of a specified residential property, that person will also be deemed to be the purchaser of that specified residential property for the purpose of this paragraph 1.2.

- 1.4 The Vendor will make available show flat(s) at the Development for viewing by the interested parties from 10:00 a.m. to 1:00 p.m. and 2:00 p.m. to 7 p.m. from 20 August 2025 to 27 August 2025 (including Saturday, Sunday and Public Holidays). One day advanced booking before the viewing is required. - 3.1 Balloting will be used to determine the order of priority in selection of the specified residential properties. Details are as follows.

The ballot results, including "Registration Number of Registration of Intent", "Priority Number", "Registration Time Slots" for registrants and "Group" will be made available at the Vendor's designated website for the Development (www.urakaitak.hk) at or before 2:00 p.m. on 28 August 2025 for viewing. The registrant(s) will not be separately notified of the ballot results. The Vendor reserves the right at any time of to change and/or adjust the date of balloting and the time of ballot results announcement.

**4. Registration:

4.1 On the First Date of the Sale, the registrant(s) shall personally or by an appointed attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor attend the Sales Office according to “Registration Time Slots” in the ballot results as mentioned in Paragraph 3.1 above. The registrant(s) must bring along: -

The registrant(s) whose identity(ies) has/have been verified by the Vendor shall proceed to select the specified residential properties. **5. Flat Selection on the First Date of the Sale:

5.1 After completion of the registration as mentioned in Paragraph 4.1 above, a registrant under the same Group shall proceed to select one specified residential property which is still available at the time of selection in the order of priority according to his/her respective Priority Number. If by the time of completion of registration and verification of identities procedures for all the registrants of a Group, the registrants of the previous Group(s) have not yet finished the selection of specified residential properties, the selection and sale of specified residential properties for that Group shall not commence until the registrants of the previous Group(s) have finished the selection of specified residential properties. The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and/or facilitating smooth sale of the specified residential properties, to change and/or adjust the time of flat selection. Any changes to the time of flat selection will be announced at the Sales Office. Registrants will not be notified separately of such changes.

In case it is not reasonably practicable for the registrant to view the selected specified residential property, the Vendor will make a comparable residential property available for viewing by the registrant. The Vendor reserves the right at any time to change and/or adjust the viewing arrangement of specified residential properties.

- 5.4 If a registrant has successfully selected a specified residential property, after the viewing of the selected specified residential property or comparable unit referred to in Paragraph 5.3 (or after the registrant decides not to view the selected specified residential property or comparable unit), the registrant shall personally enter into a Preliminary Agreement for Sale and Purchase of the selected specified residential property with the Vendor forthwith. If the registrant shall fail to enter into a Preliminary Agreement for Sale and Purchase for the selected specified residential property on the same date of flat selection before close of the Sales Office, the registrant shall be immediately disqualified from selecting and purchasing any specified residential property and the selection of specified residential property made by them shall be cancelled.

The Vendor reserves its absolute discretion to allow or reject the registrant to add any person(s) for signing the Preliminary Agreement for Sale and Purchase. Such person(s) shall bring along his/her/their H.K.I.D. Card(s), Passport(s) or such other identification document(s) to the Vendor's satisfaction (as the case may be) and personally attend the Sales Office and, upon acceptance by the Vendor, sign the relevant Preliminary Agreement for Sale and Purchase together with the registrant(s). Registrants are not allowed to remove any name which appeared in the Registration of Intent.
“Close relative” of a registrant means a spouse, parent, child, brother and sister of that registrant or any individual comprising that registrant provided that the registrant has provided valid supporting documents on spot to prove the relationship to the satisfaction of the Vendor. Whether such spouse, parent, child, brother and sister is a “close relative” of the registrant shall be subject to the final decision of the Vendor which shall be binding on any person.

Card(s), Passport(s) or such other identification document(s) to the Vendor's satisfaction (as the case may be) of the registrant if unused cashier's order(s) is/are to be collected by the authorized person) of the registrant, the original receipt for Registration of Intent, and (if applicable) a valid letter of authorization (in the form prescribed by the Vendor) and a copy of the H.K.I.D.
